From the table above, Imports of merchandise trade into the Republic of Trinidad and Tobago (ROTT) decreased by 8.04% from January - February, and increased by 8.34% from February - March. Exports decreased by 30.89% from January - February, and increased by 62.32% from February - March. Foreign exports significantly increased by 151.71% from January - February, and slightly increased by 0.23% from February - March. Balance of trade was mostly favorable, since it decreased by 32.94% (January - February), and increased by 96.21% (February - March).






The ROTT key export of oil, gas and petro-chemicals aggregated to:

This amounted to a decrease of \$1750.83 TT Mn (25.86%) from January to February, and an increase of \$2981.8 TT Mn (59.39%) from February to March.

The three (3) largest contributors to the changes during the January to February period were \$1115.18 TT Mn from the sale of Alcohols; saturated monohydric, methanol (methyl alcohol), \$962.11 TT Mn from the sale of Ammonia; anhydrous and \$397.66 TT Mn from the sale of Alcohols; saturated monohydric, methanol (methyl alcohol).







For the Period January to March


