From the table above, Imports of merchandise trade into the Republic of Trinidad and Tobago (ROTT) increased by 16.1% from July - August, and decreased by 13.32% from August - September. Exports increased by 45.38% from July - August, and decreased by 12.38% from August - September. Foreign exports decreased by 23.8% from July - August, and increased by 3.98% from August - September. Balance of trade was mostly favorable, since it increased by 67.45% (July - August), and decreased by 7.76% (August - September).






The ROTT key export of oil, gas and petro-chemicals aggregated to:






