
# QUARTERLY GDP 3RD QUARTER, 2022


#### Constant (2012) Price GDP

The Quarterly Constant (2012) Price GDP increased by TT\$ 1,637.1 Mn or 4.5% from TT\$36,102.7 Mn to TT\$37,739.8 Mn in 3rd Quarter 2022 over 2nd Quarter 2022. The Quarterly Constant Price GDP recorded an increase of 2.5% in 3rd Quarter 2022 from TT\$36,829.3 Mn. in 3rd Quarter 2021.

#### **Current Price GDP**

The Quarterly Current Price GDP increased by TT\$2,062.3 Mn or 4.2% from TT\$49,304.6 Mn in 2nd Quarter 2022 to TT\$51,366.9 Mn in 3rd Quarter 2022. The Quarterly Current Price GDP increased significantly by TT\$10,288.3 Mn or 25.0% from TT\$41,078.6 Mn in 3rd Quarter 2021.

# Special points of interest

- The Gross Domestic product is a measure of all the goods and services produced by a country, usually over a quarter or year
- The CSO follows the System of National Accounts, 2008 methodology
- The International Standard Industrial Classification, revision 4 is adopted

#### Constant Price GDP, Analysis of Percentage Contribution, 3rd Quarter 2022

Trade and Repairs, Manufacturing and Financial and Insurance Activities were the top three industries contributing 49.2% to Constant (2012) Price GDP in 3rd Quarter 2022.

In 3rd Quarter 2021, the top three industries were also Trade and Repairs, Manufacturing and Financial and Insurance Activities, contributing 23.3%, 17.9% and 8.4% respectively to Constant (2012) Price GDP.

The Percentage Contribution is calculated by diving the Industry GDP by GDP at Producers' Prices.

three industries contributing 57.4% to Current Price GDP in 1st Quarter 2022.

In 3rd Quarter 2022, the top three industries were Manufacturing, Trade and Repairs and Natural Gas Exploration and Extraction, contributing 22.4%, 19.6% and 15.3% respectively to Current Price GDP.

#### **Basic Prices**

The basic price is the amount receivable by the producer exclusive of taxes payable on products and inclusive of subsidies receivable on products. The equivalent for imported products is c.i.f. (cost, insurance and freight) value, i.e. the value at the border of the importing country

#### **Producer Price**

The producer price is the amount receivable by the producer inclusive of taxes on products except deductible value added tax and exclusive of subsidies on products. The equivalent for imported products is the c.i.f. value plus any import duties or other taxes on imports (minus any subsidies on imports)

Producer prices = Basic prices + taxes on products (excluding VAT) subsidies on products

#### **Purchaser Price**

The purchaser price is the amount payable by the purchaser. This includes trade margins realised by wholesalers and retailers (by definition, their output) as well as transport margins (i.e. any transport charges paid separately by the purchaser) and nondeductible VAT.

GDP at Purchaser Prices = agriculture value added + industry value added + services value added -FISM + net taxes on products

## ENERGY SECTOR—CONSTANT (2012) PRICES

The Energy Sector accounted for 30.5% of Constant (2012) Price GDP in 3rd Quarter 2022 with a 6.7% expansion recorded in this Sector over 2nd Quarter 2022. In 3rd Quarter 2022 a 5.4% increase was recorded over 3rd Quarter 2021.

All Industries in the Energy Sector contributed to the 6.6% increase in GDP between 2nd Quarter 2022 and 3rd Quarter 2022 with the exception of Crude Oil Exploration and Extraction which declined marginally by 0.04%.

The following table gives a breakdown of the energy Industries that contributed to the 6.6% increase in GDP in 3rd Quarter 2022.

#### **ENERGY SECTOR—CURRENT PRICES**

The Energy Sector accounted for 38.5% of Current Price GDP in 3rd Quarter 2022 with a 4.1% increase in this Sector over 2nd Quarter 2022. There was a significant increase of 72.1% recorded in 3rd Quarter 2022 over 3rd Quarter 2021.

The following Industries in the Energy Sector contributed to the 4.1% increase in GDP between 2nd Quarter 2022 and 3rd Quarter 2022:

- Natural Gas Exploration and Extraction 15.4% compared with a 5.7% increase in 2nd Quarter 2022. Of note is a significant increase of 132.4% recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Asphalt 33.5% compared with a significant increase of 127.8% in 2nd Quarter 2022. An increase of 50.3% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Petroleum Support Services 31.3% compared with a significant increase of 155.9% in 2nd Quarter 2022. An increase of 32.6% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Refining 20.9% compared with a decline of 14.0% in 2nd Quarter 2022. Of note is a significant increase of 175.7% observed in 3rd Quarter 2022 over 3rd Quarter 2021.

Offsetting the increase of 4.1% in the Energy Sector Current Price GDP in 3rd Quarter 2022 were decreases recorded in:

- Crude Oil Exploration and Extraction 12.2% compared with an increase of 14.8% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 28.8% was recorded over 3rd Quarter 2021;
- Condensate Extraction of 11.9% compared with an increase of 17.8% in 2nd Quarter 2022. In 3rd Quarter 2022, an increase of 38.4% was recorded over 3rd Quarter 2021;
- Manufacture of Petrochemicals of 8.7% compared with a decline of 1.5% in 2nd Quarter 2022. In 3rd Quarter 2022, an increase of 26.7% was recorded over 3rd Quarter 2021.
- Petroleum and Natural Gas Distribution 2.5% compared with a decline of 1.5% in 2nd Quarter 2022. In 3rd Quarter 2022, an increase of 34.3% was recorded over 3rd Quarter 2021.

#### **Energy Sector**

In 2017, the CSO migrated to the International Standard industrial Classification (ISIC) Revision 4 to represent the industries in the GDP estimation.

The organization recognizes the importance of the Energy Sector to the Trinidad and Tobago economy and has included the main industries in this Sector as Memo items at the bottom of the GDP Tables.

The industries that comprise the Energy Sector are:


Percentage Change in Selected Energy Sector Volume Indicators Graphical Representation - Constant (2012) Prices









#### Percentage Change in Selected Energy Sector Value Indicators Graphical Representation - Current Prices

## NON - ENERGY SECTOR—CONSTANT (2012) PRICES

The non- Energy Sector accounted for 69.5% of Constant Price GDP in in 3rd Quarter 2022 compared with 70.1% in 2nd Quarter 2022 and 70.3% in 3rd Quarter 2021. There was an increase of 3.6% in this Sector in 3rd Quarter 2022, compared with an increase of 2.2% recorded in 2nd Quarter 2022. In 3rd Quarter 2022 the Energy Sector increased by 1.2% over 3rd Quarter 2021.

The following Industries in the Non-Energy Sector contributed to the 3.6% increase in non-Energy GDP between 2nd Quarter 2022 and 3rd Quarter 2022:

- Transport and Storage 18.4% compared with a 2.8% increase in 2nd Quarter 2022. An increase of 38.5% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Textiles, clothing, leather, wood, paper and printing 13.5% compared with a 4.1% increase in 2nd Quarter 2022. An increase of 11.5% in 3rd Quarter 2022 was recorded over 3rd Quarter 2021;
- Construction 10.5% compared with a decline of 6.4% in 2nd Quarter 2022. A decrease of 23.3% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Trade and Repairs less Petroleum and Natural Gas Distribution 6.6% compared with a 5.0% increase in 2nd Quarter 2022. A decline of 1.2% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021; and
- Electricity less Natural Gas Bulk Distribution 3.9% compared with an increase of 0.1% in 2nd Quarter 2022. A decrease of 1.4% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021.

The 3.6% expansion in the non Energy Sector in Constant Prices GDP was offset by decreases in the following industries:

- Quarrying, 7.7% decrease compared with a 0.9% decrease in 2nd Quarter 2022. In 3rd Quarter 2022 an decline of 5.7% was recorded over 3rd Quarter 2021;
- Manufacture of Chemicals and Chemical Products, 4.0% decrease compared with a 5.5% increase in 2nd Quarter 2022. A 4.6% increase was recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Agriculture, Forestry and Fishing, 3.0% decrease compared with an 2.0% increase in 2nd Quarter 2022. A decline of 3.1% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021;
- Other Manufactured Products decreases of 1.3% and 1.5% in 3rd Quarter and 2nd Quarter 2022 respectively. A 1.3% decline in 3rd Quarter 2022 over 3rd Quarter 2021 was recorded.

Non-Energy Manufacturing Constant (2012) Price GDP decreased marginally by 0.03% in 3rd Quarter 2022 compared with a 5.8% increase in 2nd Quarter 2022 and a 13.4% increase over 3rd Quarter 2021.

#### Non -Energy Sector

In 2017, the CSO migrated to the International Standard industrial Classification (ISIC) Revision 4 to represent the industries in the GDP estimation.

The organization recognizes the importance of the Non-Energy Sector to the Trinidad and Tobago economy and has included a brief analysis of the industries in this Sector.

## NON - ENERGY SECTOR—CURRENT PRICES

The non- Energy Sector accounted for 61.5% of Current Price GDP in in 3rd Quarter 2022 compared with 61.5% in 2nd Quarter 2022 and 72.0% in 3rd Quarter 2021. There was an increase of 4.2% in this Sector in 3rd Quarter 2022, compared with an increase of 3.6% recorded in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 6.8% was recorded over 3rd Quarter 2021.

The following Industries in the Non-Energy Sector contributed to the 4.2% increase in non-Energy GDP between 2nd Quarter 2022 and 3rd Quarter 2022:

- Transport and Storage 24.4% compared with a 9.3% increase in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 55.0% was recorded over 3rd Quarter 2021;
- Textiles, clothing, leather, wood, paper and printing 13.0% compared with a 5.1% increase in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 13.4% was recorded over 3rd Quarter 2021;
- Construction 10.5% compared with a decline of 4.8% in 2nd Quarter 2022. In 3rd Quarter 2022 a decrease of 18.0% was recorded over 3rd Quarter 2021;
- Trade and Repairs less Petroleum and Natural Gas Distribution 6.0% compared with a 7.0% increase in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 7.1% was recorded over 3rd Quarter 2021; and
- Human Health and Social Work 4.6% compared with a decline of 4.7% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 0.9% was recorded over 3rd Quarter 2021.

The 4.2% expansion in the non Energy Sector in Current Prices GDP was offset by decreases in the following industries:

- Manufacture of Chemicals and Chemical Products a 9.0% decrease compared with a 27.2% decrease in 2nd Quarter 2022. In 3rd Quarter 2022 a 9.7% decrease was recorded over 3rd Quarter 2021;
- Quarrying, 7.2% compared with a marginal increase of 0.1% in 2nd Quarter 2022. In 3rd Quarter 2022, a decline of 3.1% was recorded over 3rd Quarter 2021;
- Other Manufactured Products a 2.6% decrease compared with a 3.6% increase in 2nd Quarter 2022. In 3rd Quarter 2022, a 36.2% increase was recorded over 3rd Quarter 2021; and
- Agriculture, Forestry and Fishing a 2.6% decrease compared with a 0.1% decrease in 2nd Quarter 2022. In 3rd Quarter 2022 a 7.9% decrease was recorded over 3rd Quarter 2021.

Non-Energy Manufacturing Current Price GDP increased marginally by 0.03% in 3rd Quarter 2022 compared with a 4.6% decrease in 2nd Quarter 2022. In 3rd Quarter 2023 a 15.1% increase was recorded over 3rd Quarter 2021.





#### MANUFACTURING SECTOR

Using the ISIC Rev 4 classification, the Manufacturing Sector is comprised of the following Industries:

- Food, Beverages and Tobacco Products
- Textiles, Clothing, Leather, Wood, Paper and Printing
- Petroleum and Chemical
  Products
- Other Manufactured
  Products

It should be noted that Petroleum and Chemical Products includes Refining and Petrochemicals and is presented as part of the Energy Sector in the Memo Items of the GDP tables

#### Constant vs Current Price Gross Domestic Product

Constant Price Gross Domestic Product is also referred to as Real GDP.

Constant Price GDP refers to the volume level of GDP, since the estimates value of GDP are expressed in terms of a base period. The base period for the Quarterly GDP is 2012.

Current Price Gross Domestic Product is also referred to as Nominal GDP.

Current Price GDP measures the actual prices in the economy with no adjustments for inflation.

#### **MANUFACTURING SECTOR - Constant Prices**

The Manufacturing Sector accounted for 18.6% of Constant Price GDP in 3rd Quarter 2022 compared with 18.8% in 2nd Quarter 2022 and 17.9% in 3rd Quarter 2021. This Sector's performance improved by 3.5% 3rd Quarter 2022 compared with a marginal decline of 0.1% in 2nd Quarter 2022. An increase of 6.6% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021.

An analysis of the Industries that comprise the Manufacturing Sector indicates that in the 3rd Quarter 2022, Food, Beverages and Tobacco Products decreased by 0.5%; Textiles, Clothing, Leather, Wood, Paper and Printing increased by 13.5%; Petroleum and Chemical Products increased by 5.9% and Other Manufactured Products decreased by 1.3% over the previous Quarter. This compares with an increases of 7.1%, 4.1% and 1.5% respectively in Food, Drink and Tobacco Products; Textiles, Clothing, Leather, Wood, Paper and Printing and Other Manufactured Products and a decline of 4.0% in Petroleum and Chemical Products observed in 2nd Quarter 2022.

Manufacture of textiles, wearing apparel, leather and related products and manufacture of wood and paper products; printing and reproduction of recorded media subindustries were the primary contributors to the increase in the Textiles, clothing, leather, wood paper and printing industries. These sub-industries recorded 22.8% and 2.8% increases respectively in 3rd Quarter 2022 compared with increases of 6.0% and 1.9% respectively in 2nd Quarter 2022.

With regard to Petroleum and chemical products, the Manufacture of coke and refined petroleum products, Manufacture of chemical and chemical products and Petrochemicals these sub-industries increased by 9.2%, 4.7% and 5.5% respectively in 3rd Quarter 2022. This compared with declines of 5.3%, 3.5% and 4.2% recorded in 2nd Quarter 2022.

The decline of 0.5% in the Food, beverages and tobacco industry was due to downward movements in:

- Manufacture of dairy products 0.6% in 3rd Quarter 2022 compared with an increase of 2.6% in 2nd Quarter 2022;
- Manufacture of bakery products 0.5% in 3rd Quarter 2022 compared with an increase of 2.6% in 2nd Quarter 2022;
- Manufacture of Miscellaneous food processors 7.2% in 3rd Quarter 2022 compared with a decrease of 5.1% in 2nd Quarter 2022; and
- Manufacture of Tobacco products 13.4% in 3rd Quarter 2022. There was no change recorded in 2nd Quarter 2022.

#### **MANUFACTURING SECTOR - Current Prices**

The Manufacturing Sector accounted for 22.4% of Current Price GDP in the 3rd Quarter 2022 compared with 23.2% in 2nd Quarter 2022 and 20.3% in 3rd Quarter 2021. The Sector recorded an increase of 0.5% in 3rd Quarter 2022 compared with a decline of 0.9% in 2nd Quarter 2022. A significant increase of 37.8% was recorded in 3rd Quarter 2022 over 3rd Quarter 2021.


The following Manufacturing Industries recorded increases in 3rd Quarter 2022:


- Food, Beverages and Tobacco 0.5% compared with a 7.2% increase in 2nd Quarter 2022. In 3rd Quarter 2022, an increase of 19.0% was recorded over 3rd Quarter 2021;
- Textiles, clothing, leatherwood, paper and printing 13.0% compared with a 5.1% increase in 2nd Quarter 2022 . In 3rd Quarter 2022, an increase of 13.4% was recorded over 3rd Quarter 2021; and
- Petroleum and Chemical Products, an increase of 0.5% compared with a decline of 5.6% in 2nd Quarter 2022 . In 3rd Quarter 2022 an increase of 57.6% was recorded over 3rd Quarter 2021.

The two sub-industries that accounted for the increase of 13.0% in Textiles, clothing, leather, wood, paper and printing were:

- Manufacture of textiles, wearing apparel, leather and related products which increased by 23.3% in 3rd Quarter 2022 and by 5.7% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 25.9% was recorded over 3rd Quarter 2021; and
- Manufacture of wood and paper products; printing and reproduction of recorded media which increased by 2.4% in 3rd Quarter 2022, 4.5% in 2nd Quarter 2022. In 3rd Quarter 2022 and increase of 1.1% was recorded over 3rd Quarter 2021.

Offsetting the increases in the Manufacturing Sector was a decline of 2.0% in Other Manufactured Products in 3rd Quarter 2022 compared with an increase of 8.0% in 2nd Quarter 2022. In 3rd Quarter 2022, an increase of 7.1% was recorded over 3rd Quarter 2021.





#### AGRICULTURE, FORESTRY AND FISHING

#### **CONSTANT PRICES**

The Agriculture, Forestry and Fishing Industry declined by 3.0 in 3rd Quarter 2022 compared with an increase of 2.0% recorded in 2nd Quarter 2022. In 3rd Quarter 2022 a decline of 3.1% was recorded over 3rd Quarter 2021.

Declines in Crops of 4.8% and Livestock of 2.7% were the main contributors to the 3.0% decrease recorded in this industry. Offsetting this decline was an increase of 8.9% in Eggs and Poultry recorded in 3rd Quarter 2022.

#### **CURRENT PRICES**

The Agriculture, Forestry and Fishing Industry declined by 2.6% in 3rd Quarter 2022 compared with a 1.2% increase recorded in 2nd Quarter 2022. In 3rd Quarter 2022, a decline of 0.2% was recorded over 3rd Quarter 2021.

Decreases in Crops of 2.9% and Fishing of 10.1% were the main contributors to the 2.6% decline recoded in this industry. Offsetting this decline were increases of 13.6% in Eggs and Poultry and 5.3% in Livestock recorded in 3rd Quarter 2022.

#### **FINANCIAL SECTOR**

#### **CONSTANT PRICES**

Financial and Insurance Activities contracted by 0.8% in 3rd Quarter 2022 compared with a decline of 1.1% observed in 2nd Quarter 2022. In 3rd Quarter 2022, a decrease of 1.9% was recorded over 3rd Quarter 2021.

In 3rd Quarter 2022, Financial Service Activities, except Insurance and Pension Funding declined by 0.8%, with Insurance, Reinsurance and Pension Funding, except Compulsory Social Security and Activities Auxiliary to Financial Service Activities recording negligible movements in their activities.

This compares with an decrease of 1.4% observed in 2nd Quarter 2022 for Financial Service Activities, except Insurance and Pension Funding and negligible movements in the other two sub-industries - Insurance, Reinsurance and Pension Funding, except Compulsory Social Security and Activities Auxiliary to Financial Service Activities.

#### **CURRENT PRICES**

Financial and Insurance Activities increased by 2.2% in 3rd Quarter 2022 compared with a 0.3% decrease in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 3.2% was recorded over 3rd Quarter 2021.

In the 3rd Quarter 2022, Financial Service Activities, except Insurance and Pension Funding increased by 2.7% and Insurance, Reinsurance and Pension Funding, except Compulsory Social Security increased by 1.0% with Activities Auxiliary to Financial Service Activities recording negligible movement.

In the 2nd Quarter 2022, Financial Service Activities, except Insurance and Pension Funding decreased by 0.7% and Insurance, Reinsurance and Pension Funding, except Compulsory Social Security increased by 0.6% with Activities Auxiliary to Financial Service Activities recording negligible movement.

#### **Financial Sector**

Based in the ISIC Rev 4 classification, the Financial Sector comprises:

- Financial Service Activities, except Insurance and Pension Funding
- Insurance, Reinsurance and Pension Funding, except Compulsory Social Security
- Activities Auxiliary to Financial Service and Insurance Activities

#### **Trade and Repairs**

Based in the ISIC Rev 4 classification, the Trade and Repairs Industry comprises:

- Wholesale Trade
- Retail Trade
- Vehicle Sales
- Vehicle Repairs
- Petroleum Distribution and
- Natural Gas Distribution

It should be noted that Petroleum and Natural Gas Distribution are also presented as part of the Energy Sector in the Memo Items of the GDP tables







#### **TRADE AND REPAIRS - Constant Prices**

Trade and Repairs Industry expanded by 6.3% in in 3rd Quarter 2022 compared with an increase of 5.0% in 2nd Quarter 2022. In 3rd Quarter 2022 a decrease of 0.6% was observed over 3rd Quarter 2021.

The following movements were recorded for all the sub-industries in Trade and Repairs in the 3rd Quarter 2022:

- Wholesale Trade fell by 4.0% compared with an increase of 5.5% in 2nd Quarter 2022. In 3rd Quarter 2022 a decline of 14.0% was recorded over 3rd Quarter 2021;
- Retail Trade increased by 8.8% compared with an increase of 1.9% in 2nd Quarter 2022. In 3rd Quarter 2022 a 3.1% increase was recorded over 3rd Quarter 2021;
- Vehicle Sales increased by 18.5% compared with an increase of 16.7% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 8.8% was recorded over 3rd Quarter 2021;
- Vehicle Repairs fell by 0.6% compared with a decrease of 0.6% in 2nd Quarter 2022. In 3rd Quarter 2022 a decline of 2.3% was recorded over 3rd Quarter 2021;
- Petroleum Distribution fell by 2.4% compared with an increase of 9.9% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 20.0% was recorded over 3rd Quarter 2021;
- Natural Gas Wholesalers increased by 8.5% compared with a decrease of 2.6% in 2nd Quarter 2022. In 3rd Quarter 2022 a decrease of 2.2% was recorded over 3rd Quarter 2021.

#### **TRADE AND REPAIRS - Current Prices**


Trade and Repairs Industry expanded by 5.4% in in 3rd Quarter 2022 compared with increases of 7.0% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 8.9% was recorded over 3rd Quarter 2021.

The following movements were recorded for all the sub-industries in Trade and Repairs in the 3rd Quarter 2022:


- Wholesale Trade increased by 0.1% compared with an increase of 5.9% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 4.8% was recorded over 3rd Quarter 2021;
- Retail Trade increased by 5.9% compared with an increase of 4.7% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 7.4% was recorded over 3rd Quarter 2021;
- Vehicle Sales increased by 18.0% compared with an increase of 16.9% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 10.8% was recorded over 3rd Quarter 2021;
- Vehicle Repairs declined fell by 0.6% compared with decreases of 0.6% in 2nd Quarter 2022. In 3rd Quarter 2022 a decline of 2.4% was recorded over 3rd Quarter 2021;
- Petroleum Distribution fell by 0.2% compared with an increase of 35.2% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 63.6% was recorded over 3rd Quarter 2021;
- Natural Gas Wholesalers fell by 2.8% compared with an increase of 0.1% in 2nd Quarter 2022. In 3rd Quarter 2022 an increase of 32.1% was recorded over 3rd Quarter 2021.
